### President's "Drop-Offs"

With the fluid nature of the corona virus pandemic, it is difficult to plan for our 2020 summer. I can only imagine that business owners are in the same situation. So, here are some items to report on:

- 1. **ANNUAL MEETING**: We are targeting Saturday, June 20th, 2020 at Camp Joy for our annual meeting. It will be subject to the then effective state rules for gatherings, what Camp Joy may be planning for its campus, and if a useable drug therapy to reduce the risk of the virus is available or social distancing guidelines have been changed. We could certainly try to meet outdoors, we could do some type of on-line meeting, or we could just cancel for 2020. As more becomes known, I will share it with you.
- 2. **SMALL NORTHERN TOURNAMENT**: This is like the annual meeting. Tentatively, we are targeting Saturday, June 6th, 2020 (D Day) for the event. Camp Joy has decided to not host this event, so we will need to find an alternative host site and qualified organization (not-for-profit) to take any donated northern fillets. We are open to any ideas you may have in that regard.
  - Unfortunately, in North Dakota all fishing tournaments have been cancelled through May and could be extended for the summer. Thus far, the Minnesota fishing season is scheduled to start on May 9th, 2020 even though the Governor's Opener has been cancelled. I have not seen anything in Minnesota relative to fishing tournaments. If you see more, please pass it along. We will continue to monitor and update members on the small northern tournament as well. (P.S. We will need several volunteers besides the Board members to conduct this event.)
- 3. **WATER LEVELS**: Just a reminder that once the ice is off the lake, we will report water levels every two weeks and post it on the SLPOA website. The water level charting from 2019 is posted there currently.
- 4. **SLPOA MEMBERS DIRECTORY**: We plan to have our 2020 lake directory complete and printed before the annual meeting in June. BUT, print shops are closed currently. Much depends on when they are allowed to return to work and tackle any accumulated workloads. Who thought a couple months ago that printing would be impacted by a global pandemic?
- 5. **INVASIVE SPECIES**: Just a reminder that like the corona virus, we DO NOT want to spread invasive species like zebra mussels into Star Lake. Although the DNR lists Star Lake as a site because of potential upstream contamination, there has been no colonies of zebra mussels identified in Star Lake. Let's continue to try to keep it that way!
- 6. **MEMBERSHIP** (for full disclosure I am borrowing much of this language from Peggy Maasjo's Spring 2019 article on membership): All organizations like SLPOA are only as strong as its members make it. Our Board of Directors is very proud that we represent 229 members. It is our highest total ever! THANK YOU for your trust!

As we see more and more proposed development on Star Lake, it is important that we preserve and protect the lake for future generations. We are all in this together! There is only one Star Lake. The more members we have, the better chance we have of working together to accomplish our mission. There is power in numbers.

Our annual membership dues are \$30.00. With that money, your association maintains water safety buoys, monitors the water quality of the lake, updates members with two annual newsletters, maintains an updated website, reviews and interacts with government on projects, sends out emails on urgent matters concerning the lake, works to improve the fishery, hosts a lake wide picnic in conjunction with a volunteer member, and hosts an annual meeting which allows members to vote on bylaws, projects, and issues concerning the lake.

With our fluid virus battle, PLEASE renew your 2020/2021 membership dues as soon as possible. There is a membership form on the last page of this newsletter as well as on the SLPOA website. It really helps if you share your current email address with your renewal! It speeds getting correspondence to you and keeps our mailing cost low.

## Corona Virus 2020 Message

## Lakescaping Grant Program (SLPOA)

The Star Lake Property Owners' Association (SLPOA) and its Board of Directors are committed to preserving this natural resource to include but not limited to:

- Its excellent water quality
- Its bountiful fishery
- Its natural wildlife haven
- Its ordinary and proper development

To fulfill and enhance its mission, the SLPOA offers a lakescaping shoreline restoration grant program to members with support from the East Otter Tail Soil & Water Conservation District Office. The grant program is aimed at creation of natural shoreline buffers and erosion control projects on and around Star Lake. The program promotes the use of native plants, grasses, and trees.

#### **GRANT PROCESS**

- To be considered, the project partner must be a current member in good standing.
- The potential project partner must submit a written application with a full description of the project being considered. The description should include a complete project location, project needs listing, and the type of native plants, grasses, or trees to be included in the shoreline restoration.
- The SLPOA Board of Directors will review the written application and project description and ask for information to move the project forward as necessary.
- If the project description is deemed to meet SLPOA requirements, the SLPOA Board will work with the East Otter Tail Soil & Water Conservation District Representatives to assist the member in completing the Conservation District's cost share and other appropriate program documents.
- The SLPOA Board retains full right to approve or deny the project application based not only on the merits of the project but also the current financial position of the Association.
- All applications are to be submitted to the attention of the SLPOA President

#### **GRANT CRITERIA**

- A written grant application with the project description is required to be submitted
- If approved, the grantee is expected to maintain the location for the project for a period of at least 10 years
- The SLPOA may inspect or appoint someone with the required expertise to inspect the project upon completion and annually thereafter if desired
- 50% of the grant will be paid at the time the project is approved and 50% will be provided upon completion of the project inspection and approval by the SLPOA Board of Directors.
- The grant amount can be up to a maximum of \$2000.00 per project. Partial funding of projects will be considered.
- If an approved, funded, and completed project is abandoned or radically altered before the end of the 10 year commitment period, the SLPOA will receive a prorated refund amount of its cost share amount for each year not completed (ie: if the project has existed for 6 years and radically changed, the Association will be entitled to receive 40% of the grant amount in the form of a cash refund)
- Rip Rap Rock is not encouraged for grant dollars but may be considered if erosion control is clearly
  enhanced by its inclusion in a project
- The project partner will be responsible for maintenance of the site

Native shoreland buffers are a valuable tool for maintaining and improving water quality and riparian ecosystems. These buffers are designed to filter pollutants from stormwater runoff, reduce erosion, and provide habitat for a variety of aquatic and terrestrial species. Your lake association is proud to be able to offer this program to its members!
